# b. New State Law Requires Posting of Meeting Agendas and new Process for Adding Items to Agendas

Act 65 of 2021 went into effect on August 29, 2021 and requires public agencies in Pennsylvania to post meeting agendas, on-line and at their office, at least 24 hours prior to a meeting. The Act also specifies that items may only be added to an agenda that has been posted with the approval of a majority of members of the voting entity.

The Township Manager will review these new requirements with the Board. Please see the Manager's memo, "New Agenda Procedures to Comply with the amended Pennsylvania Sunshine Act" that is included with the agenda materials as Item 1b.

#### c. Additions to the Posted Agenda

## 1) Proposed Policy for Adding Items to the Agenda

The Manager recommends the Board adopt the following guidance for adding items to a posted agenda:

The tentative agenda for the Patton Township Board of Supervisors is typically published on the Friday prior to the Wednesday meeting. An Updated Agenda is typically published on the Tuesday prior to a Wednesday meeting. The Updated Agenda shall be considered the "posted" agenda in accordance with Act 65 of 2021.

## 1. CALL TO ORDER (Continued)

## c. Additions to the Posted Agenda (Continued)

### 1) Proposed Policy for Adding Items to the Agenda (Continued)

At this time, the Chair may announce and/or ask the other Board members for the addition of agenda items that constitute Emergency Business or are considered de minimas in nature and do not involve the expenditure of funds or entering into a contract or agreement. The Chair shall determine if the items do constitute Emergency Business or are considered de minimas in nature and will determine the placement of each such added item within the meeting agenda.

Any Board member wishing to add an item to the agenda that is not Emergency Business and not considered de minimas in nature shall ask for recognition by the Chair and shall make a motion to add an item, including stating the nature of the item and reason for changing the agenda. If the motion is seconded, the Chair shall oversee discussion and a vote on the motion to add the item. If the motion is approved by a majority vote of the individuals present and voting, the item shall be added to the agenda. The Chair shall determine the placement of the added item within the meeting agenda.

If adopted, the above language will be included in future agendas.

## 2) Additions to the Posted Agenda

If the above guidance is adopted, the Board should consider the addition of any new items to the agenda as detailed above.

## 3. PRESENTATIONS / PUBLIC HEARINGS

## a. Economic Development Proposal: Incentive Pool to Attract Direct Air Service to Charlotte, North Carolina

The Centre County Commissioners are reaching out to municipalities and other interested parties to help build an incentive pool to attract American Airlines to add air service to Charlotte International Airport with 12 flights per week. The Commissioners have pledged \$250,000 in American Rescue Plan Act (ARPA) funds to this effort. Please see Item 3a.1 in the attached agenda materials for additional detail on this matter.

Representatives from the County Commissioners and the Centre County Airport Authority will be in attendance. The Commissioners are asking the Township to consider a contribution of \$10,000 to \$15,000 towards the incentive pool. Potentially, the Board could use previously encumbered funds being held for economic development or the Township's ARPA funds for this incentive.

The Manager notes that many economic development discussions over the past 10 years have identified the limitations of our local air service as a problematic issue when trying to attract new employers to the region.

The application for the award was developed by the Recreation Advisory Committee with assistance from Susan Wheeler, PW Project Manager, and Trish Meek, Senior Planner for the Centre Region Planning Agency.

# c. Process for Implementing Recommendations from the Policing and Communities of Color Task Force Report

At the <u>August meeting</u> the Board received an overview of the subject report and recommendations form the Task Force Chair. As noted, the Task Force was convened in 2020 by the State College Borough (SCB) and the Pennslyvania State University (PSU). The Patton Township Police Chief was the only Task Force member with specific ties to the Townshp.

As the Task Force's report was developed without any direct participation or prior review from Patton Township's governance, the Manager recommends the Board undertake a local process of additional review and deliberation prior to making decisions on adoption of the report's recommendations or findings. The Board members could take on the review function themselves or refer such to a standing Township ABC body or form a new ad-hoc group.

#### 5. PUBLIC WORKS

#### a. Update on Pickleball at Bernel Road Park

The Township's parks design consultant has provided three options to install dedicated pickleball courts in Bernel Road Park. See Item 5a.1 of the attached agenda materials.

The Manager apologizes to the Board that the conversion of 1 tennis court to 4 pickleball courts turned out to be infeasible.

The remaining feasible options include:

Exhibit A	Add three pickleball courts to Bernel Road Park.	\$121,144
Exhibit B	Convert one existing tennis court to two pickleball courts at Bernel Road Park.	\$ 34,854
Exhibit C	Convert two existing tennis courts to six pickleball courts at Bernel Road Park.	\$ 66,303

## a. Update on Pickleball at Bernel Road Park (Continued)

As stated in the memo, none of the options can be expected to be completed this fall. The consultant recommends that the Township look to a January bid and a spring start to construction.

To fund the chosen option, at this time the Manager recommends the Board obligate part of the existing cash reserve from the Parkland Acquisition and Improvement Reserve Fund – see Item 5a.2 of the attached agenda materials. This may require that the Phase 2 Bernel Road Park project be delayed until 2023. Further discussion towards potentially using American Rescue Plan funds or other sources can be taken up later this year.

Public comments received after September 3<sup>rd</sup> are included with the Updated agenda - see item 5a.3.

#### b. Update on Pickleball at Green Hollow Park

The same consultant's report (Item 5a.1) also includes an estimate of \$35,786 for converting the 4 pickleball courts at Green Hollow Park to 2 tennis courts – See Exhibit D of the attachment. As above, the consultant recommends that the Township look to a January bid. Again, the Manager recommends the Board obligate part of the existing cash reserve from the Parkland Acquisition and Improvement Reserve Fund – see Item 5a.2 of the attached agenda materials.

The agenda materials (Item 5b.1) also include a summary of the results of the "Hours of Play" survey. The Public Works Project Manager will review the results with the Board.

Supervisor Thies has submitted two motions for the Board's consideration on this matter. See attachment 5b.2.

Supervisor Trevino has requested the consultant provide an option for 1 tennis court and two pickleball courts in Green Hollow Park. See attachment 5b.3 for an illustration and cost estimate.

### c. Proposed Regulation for Small Cell Facilities in the Public Rights-of-way

The Manager will provide an overview of Act 50 of 2021 provides for the regulation of small wireless facilities in municipal rights-of-way and will preview a working draft of regulations that are needed to be in place by October 29<sup>th</sup> to address permitting of new small cell facilities that are enabled by Pennsylvania Act 50 of 2021. Please see attached Items 5c.1 and 5c.2.

### **5G Regulations**

Act 50 of 2021 (formerly HB 1621) provides for the regulation of small wireless facilities in municipal rights-of-way. It also authorizes municipalities to charge an annual fee for the use of the right-of-way, not exceeding \$270 per small wireless facility or \$270 per new utility pole with a small wireless facility, and sets the maximum permitted height of the pole and small cell facility at 50-feet. Small cells are required to comply with restrictions in place in underground utility districts and municipalities are able to develop reasonable design guidelines to minimize aesthetic impact. Municipalities have 60 days to review applications for collocation on preexisting structures and 90 days for the installation of a new structure with attached small wireless facilities.

# d. Request for Additional Funding for Bernel Road / Fox Hill Road Intersection Improvements

The developer of the adjacent property, Decibel Partners, L.P. (Decibel), have submitted a request asking the Board to consider granting additional funding toward this project (See Item 5d.1). Specifically, they request assistance toward funding the added costs resulting from contract change orders related to unstable soils encountered under the existing pavement.

Prior to beginning this public/private project the Township and Decibel did enter into an agreement holding Decibel responsible for all additional costs and debt service payments as noted below. This agreement could be amended under agreement by both parties.

The initial funding for the contract costs was provided through a loan from the Pennsylvania Infrastructure Bank (PIB).

The Township received a state grant for \$700,000 and pledged \$150,000 in township funding toward the project.

The developers have also incurred more than \$447,000 in project costs outside of the construction contract.

The contract bid amount was \$1,513,164. Change orders to the contract for addressing the unstable soils totaled over \$230,000.

## b. Energy Services Consultant Authorization

Patton Township is a participant in a consortium exploring opportunities to invest in a utility-scale solar power facility and secure a long-term source of electricity from a renewable provider. The consortium has solicited and reviewed proposals from consultants experienced in this field. The next step in the process is to vote to accept the proposal recommended by the Working Group. The State College Area School District (SCASD) has agreed to be the contracting agency for this phase of the project.

## b. Energy Services Consultant Authorization (Continued)

The Township's representative, Supervisor Betsy Whitman, will review the recommendation to engage GreenSky Development Group for the project. See the materials (Item 7b.1) included with the agenda attachments for more information.

Patton Township is responsible for 1.22% of the project costs, or less than \$1,000.

The Board should consider action to authorize Supervisor Whitman to vote to accept the working group's recommendation.

### c. Partnering with Sun United Neighbors Solar Co-op

Supervisor Betsy Whitman asks the Board to consider a proposal to become a Community Partner with Sun United Neighbors (SUN) of Pennsylvania. Please see agenda items 7c.1 and 7c.2 for further information on solar co-ops, SUN and the partnering process.

#### d. Real Estate Tax Appeal Settlement for Carnegie Inn

The Centre County Assessor has provided a recommendation (attached Item 7d.1) to the Solicitor to enter into a settlement agreement on a real estate tax appeal filed by the Carnegie Inn Limited Partnership (100 Cricklewood Drive). The settlement is proposed to avoid "the hazards and risks of litigation."

The agreement would reduce the assessed value of the property by 11.25% and reduce the Township's real estate levy by approximately \$517 per year.
