a. Noise Waiver Request: 614 Devonshire Drive

The owners of the subject home have requested a waiver from the noise requirements of <u>Chapter 105</u> of the Patton Township Code. Specifically, they request exemption to the limits on amplified music for a "client appreciation event" on Thursday, June 2nd from 6 to 10 pm.
