Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 21 year old female was cited for criminal mischief. Following an argument, the female damaged her ex-boyfriends vehicle.
- A 34 year old male was arrested and charged with escape, flight to avoid prosecution and possessing a small amount of marijuana. The male fled on foot after he was pulled over for a traffic offense. The male was apprehended a short time later hiding in a local business. While conducting the investigation, officers learned that the male was wanted by the Centre County Sheriff's Office for failing to appear for a court appearance.
- 5 arrests were made for retail theft, and 1 arrest was made for driving under the influence.
- Officers successfully served 1 warrant of the 8 warrants that they attempted to serve.
- Officers conducted 11 vacation home checks.

Use of Force: PTPD officers used force during one incident in February 2022. PTPD officers were assisting State Parole Agents who were attempting to take a male into custody for violating his parole. The male barricaded himself in a room. After negotiating with him for a while and de-escalating the situation, the male unlocked the door, but then hid in a closet. An officer pointed their taser at the male while he was brought out and handcuffed. The male was taken into custody without any further issues. There were no injuries reported by the male or by any officers on scene.

Community Relations:

- Ofc. Tuskovich spoke about drugs and alcohol with the 8th grade health classes
- Ofc. Tuskovich spoke about unsolved cases and law enforcement with the 8th grade academic literacy classes.
- Ofc. Sunderland installed a child safety seat for a township resident.
- Officers were active in the school zones during drop off and pick up hours.

Training and Department Activities

Det. Snyder, Ofc. Shaffer and Ofc. Tuskovich attended Tactical Response Team training on 2/14.

All officers received their annual update training which is required by the state. The topics for this year's training included legal updates, understanding bias, use of force, control tactics, racial profiling awareness, de-escalation strategies and a crisis intervention team update.

Chief Jolley attended the Children's Advocacy Center Advisory Committee meeting on 2/16 and the Community and Campus in Unity meeting on 2/28.

Over the past two years Det Federinko, in his role as Narcotics Detective, has contributed greatly to stem the flow of illegal narcotics and controlled substances in the Centre Region. In that time frame he has arrested numerous individuals for delivery of controlled substances. In that time frame he has also worked with the Pennsylvania Office of Attorney General and other local departments to investigate nearly twenty cases involving individuals trafficking large amounts of controlled substances into the community from large metropolitan areas. Det Federinko was the lead investigator for several of these cases, including some which were sent to the Pennsylvania State Grand Jury.

It was due to the initiative displayed by Det Federinko and his thorough and professional investigation that the delivery of dangerous drugs into the Centre Region has been significantly curtailed. His work has had a positive impact on the entire community. His actions reflect the highest credit on himself and the Patton Township Police Department.
