Enclosed are the minutes from the April Recreation Advisory Committee, which should be reviewed and accepted.

3. **GREEN HOLLOW PARK ADA PATH CONSTRUCTION**

Phase 1 of the Green Hollow Park ADA Path construction project is out for bid and is being managed through PennBid. Bids will be opened on June 18, 2021 and construction will take place in 2021. Phase 2 of the ADA path project will be constructed in 2022. The design professional for this project is YSM Landscape Architects.

4. **LEAGUE OF AMERICAN BICYCLISTS "BICYCLE FRIENDLY BUSINESS" DESIGNATION**

Ms. Wheeler, Ms. Trish Meek of the Centre Regional Planning Agency (CRPA) and the Committee prepared the Bicycle Friendly Business application for review by the Board of Supervisors. At the May 26, 2021 Board of Supervisors meeting, the Board approved the submission of the Bicycle Friendly Business application for Patton Township. The submission due date is June 10, 2021 and announcement of successful awards will be in early fall. The Patton Township application was submitted on June 3.

5. **MAY "WAS" NATIONAL BIKE MONTH**

The May 18, 2021 RAC meeting was the "Patton Township Bike Chat". It was a virtual event and it is anticipated that the next Bike Chat will be in person.

6. CIRCLEVILLE PARK BICYCLE REPAIR STATION

The first bicycle repair station in the township has been installed in Circleville Park. Its location will be added to the regional Bicycle Facility Map which is prepared by CRPA.

7. VALLEY VISTA SHARED USE PATH TO TUDEK PARK BIKE PATH CONNECTOR ROUTE PROPOSAL

As the Committee is aware, the "*Patton Township Parks and Bicycle/Pedestrian Path Plan 2020 – 2029*" provides mapping for future bicycle/pedestrian path connections throughout the Township.

In that adopted plan, one route designated as a Connector Route traverses along Devonshire Drive (and Park Lane and W. Aaron Drive) to connect the Valley Vista Shared Use Path to the Bike Path in Tudek Park in Ferguson Township.

Ferguson Township has agreed that they will contract to have sharrows painted and install directional signs along Devonshire Drive, Park Lane and West Aaron Drive. Patton Township is doing the same on the Patton Township section of Devonshire Drive. Once this project is completed it will be added as a Connector Route on the CRPA Bicycle Facility Map.

8. VALLEY VISTA SHARED USE PATH UPDATE

The Contractor CH+D has yet to finish some items on the punch list related to topsoil placement, touch up grading and seeding. That work is scheduled to be finished by June 16.

9. FUTURE POTENTIAL PICKLEBALL COURT LOCATIONS

The Board of Supervisors have been discussing pickleball in Green Hollow Park at their Board meetings. At the May 12, 2021 Board meeting the Board formed the Advisory Committee for Green Hollow Pickleball. This Advisory Committee has been meeting regularly and providing input to the Board.

The Board would like the RAC to discuss planning for the potential for future pickleball court locations. The Committee should discuss existing parks in the Township and the potential for court locations and provide input to the Board.
