Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 26 year old male was arrested for Burglary, Theft, and Receiving Stolen Property. The male entered a residence and removed property which did not belong to him.
- A 20 year old female was arrested for Stalking and Harassment. The female continued to show up at a residence even though she was uninvited and warned to stay away.
- A 35 year old male was arrested for Criminal Mischief. The male damaged property in a common area of an apartment complex.
- A 33 year old female was arrested for Retail Theft. While investigating the theft incident, officers determined that the female had a felony warrant from another state. The female was incarcerated awaiting extradition on the warrant.
- 1 arrest was made for public intoxication, 5 arrests were made for retail theft, and 4 arrests were made for driving under the influence.
- Officers successfully served 4 warrants of the 5 warrants that they attempted to serve.
- Officers conducted 18 vacation home checks.

Use of Force: PTPD officers did not use force during any incidents in the month of January, 2022.

Community Relations:

- Officers conducted multiple checks at The Centre Sports Complex during weekend events at the facility.
- Officers were active in the school zones during drop off and pick up hours.

The Patton Township Police Department welcomed Officer Adam Wolfinger to our team. Ofc. Wolfinger began his employment with Patton Township on 1/24.

Officer McCaslin,

Thank you so much for the assistance and direction you gave us when we recently fell victim to credit card fraud. Yesterday, January 26, 2022, we received the third letter from Chase VISA stating that they have finally decided to reverse the fraudulent charge of \$2461.66.

Until I spoke with you on January 16th, Chase VISA was the only company I spoke with. They were so difficult to work with. They either intentionally withheld information from us regarding the transaction or they never bothered to make the thorough investigation they claimed to have made on our behalf. They would not give us any reasoning for why they insisted that we "benefited from the transaction". Their Recovery Senior Specialist was so adamant that I had signed for the merchandise delivered to my Port Matilda, PA address. Other than finding out that the order was for a DEWALT power tool and that Federal Express had delivered the package, I could not get any other information from her. We have had a Chase credit card for over 30 years with them. Never a late payment....Always paid the balance in full each month....Never disputed a fraud charge.

You suggested that I call Home Depot. I never dreamed that they would have been so cooperative. They were also victims of this crime. I was pleasantly surprised how helpful Sergio at Home Depot Headquarters was. He immediately emailed me a copy of the online order they received, supposedly from me. This was an order for a Dewalt 20-volt MAX crimping tool, batteries, charger and case. He told me that Home Depot requested a signature for the package at the time of delivery. He provided me with the Federal Express tracking number.

I then called Federal Express and provided them the tracking number. They told me the package was delivered to Bronx, NY.

I also ran the Fed Ex tracking number. The package originated in Ohio and got as far as Duncansville, PA where there was a change of delivery address requested.

It seems that the person who created this order also created their own email address to which all order confirmation and tracking information was emailed.

I reported all of this information to Chase VISA on January 17th.

We are so bewildered at how this person got our credit card information and address.

We were so disappointed with the lack of respect and concern we received from Chase.

A huge thank you to Officer McCaslin, Patton Township Police Service; Sergio, Home Depot Headquarters; and, Evan State College Federal Express for helping us to clear up this matter.
