

Note:

Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

#### **Department Notes:**

- PTPD arrested Kevin Mullen of State College and charged him with multiple counts of Rape, Sexual Assault, and various other related charges. The investigation into this incident is still active and Detectives are looking for other potential victims.
- A 34 year old female was arrested for theft of lost/mislaid property. The female located a wallet in a shopping cart unattended in a Township store. The female stole the wallet.
- A 26 year old male and a 29 year old male were charged with possessing a small amount of marijuana and possessing drug paraphernalia. The males caused a disturbance at a Township business and officers located the contraband during their interaction.
- 3 arrests were made for public intoxication, 3 arrests were made for retail theft, and 3 arrests were made for driving under the influence.
- Officers successfully served 1 warrant. They attempted to serve 9 warrants.
- Officers conducted 6 vacation home checks.

<u>Use of Force:</u> PTPD officers used force during two incidents in November 2021. A female was transported to MNMC by EMS for a conscious alcohol overdose and mental health evaluation. At the hospital an officer had to help restrain the female as she had unbuckled herself and was trying to get off the stretcher as they pushed her into the hospital. An EMT and an officer had to push the female back onto the stretcher so that she did not fall off. The female was cited for public drunkenness. There were no injuries to the female or the officer.

Officers were dispatched to deal with a disorderly male. The male mentioned that he had smoked some marijuana and wanted help. Officers summoned EMS to transport the male to the hospital for evaluation and treatment. While waiting for EMS, the male pushed/shoved two officers. The officers guided the male to the ground where they were able to handcuff him behind his back. The male was transported to the hospital by EMS. He was cited for public intoxication and disorderly conduct. No injuries were reported by the male, or the officers involved.

#### **Community Relations:**

- Ofc. Tuskovich met with employees at Home Depot on 11/10. Home Depot donated \$1,000 to our annual shop with a cop initiative.
- Ofc. Tuskovich represented PTPD at a PennDOT/Highway Safety Network Aggressive Driving press conference on 11/12.
- Ofc. Tuskovich spoke with the 8<sup>th</sup> grade PFMS academic literacy classes about Centre County unsolved crimes on 11/16 and 11/17.
- Ofc. Shaffer gave a Drug Recognition Expert presentation to a group of middle school students.
- Officers were active in the school zones during drop off and pick up hours.

### **Training and Department Activities**

Det. Snyder, Ofc. Shaffer and Ofc. Tuskovich attended Tactical Response Team training on 11/8.

Ofc. Sallade attended training to become a hostage negotiator 11/1 through 11/5.

Ofc. Sallade and Ofc. Vardzel attended Forensic Concerns for Crash and Arson Investigations training on 11/11.

Ofc. Finochio attended AccuFit 9000 Pro Respirator Fit-Test training on 11/8. (Centre County Government, using federal Community Development Block Grant – COVID funding, purchased an AccuFit 9000 Pro respirator fit testing machine for use by Centre County EMS Agencies. Using this machine, agencies can perform an accurate, quantitative fit test of their personnel using various mask types; helping them meet the OSHA respiratory protection requirements of 29 CFR 1910.134. This machine can also be used for SCBA and gas/riot mask fit-testing)

All officers attended mandatory low light firearms training on 11/9.

PTPD welcomed Ofc. Michael Kauffman to our agency. Ofc. Kauffman was sworn-in on 11/23.

Chief Jolley attended the COG Emergency Services meeting, met with loss prevention at Target about resources Target has available to law enforcement and the Community and Campus in Unity meeting.

Performance Report

On 10/18/21, Ofc Finochio responded to an address in the Woodycrest neighborhood to check the welfare of a male who made threats of self-harm to a counseling agency. Ofc Finochio arrived at the residence and found the male to be distraught and in possession of a knife. Ofc Finochio spoke with him at length to calm him down and eventually the male folded up the knife and surrendered it. The male then agreed to go to the hospital for evaluation and treatment.

It was due to the de-escalation tactics employed by Ofc Finochio that a serious situation was peacefully resolved and that a person in crisis was provided appropriate treatment. His actions reflect the highest credit on himself and the Patton Township Police Department.
