Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 31 year old male was arrested for simple assault. Officers were dispatched to a township business for a fight in progress. Through investigation officers determined that the male attacked another person, by punching them in the facial area.
- A 44 year old male was arrested for possession of methamphetamine. An officer on bicycle patrol noticed a vehicle with an expired inspection sticker. Upon stopping the vehicle, the officer found that the male driver had a bench warrant out for his arrest. The officer took the male into custody and searched him. The officer discovered the drugs during the search.
- A 38 year old male was arrested for driving under the influence, fleeing or attempting to evade law enforcement, and hit and run. The male struck a legally parked vehicle and left the scene. An officer caught up with the vehicle and the male refused to pull over for the officer. Eventually the male did pull over. His vehicle was severely damaged.
- 25 arrests were made for retail theft and 2 arrests were made for driving under the influence.
- Officers successfully served 8 warrants of the 9 warrants that they attempted to serve.
- Officers conducted 8 vacation home checks.

Use of Force: PTPD officers used force during three incidents in the month of May 2022.

Officers pursued a vehicle that left the scene of a motor vehicle accident. The vehicle attempted to flee for a few miles. When officers were able to get the vehicle stopped, they conducted a felony stop. Officers pointed their duty weapons in the direction of the driver until they were able to safely secure him in handcuffs. No injuries were reported by the driver or by officers on scene.

Officers were dispatched to a residence to assist with a juvenile who was in crisis. The juvenile was hitting, punching, kicking, and biting his parents who were attempting to restrain him. The juvenile successfully punched his mother in her face. To prevent anyone from getting any further injury, officers restrained the juvenile's arms to the ground. Officers held the juvenile on the ground until EMS arrived to transport the juvenile. The juvenile attempted to resist and regain control to strike officers but was never successful. No injuries were reported by the juvenile or the officers on scene.

Officers were dispatched to an intoxicated male laying in the middle of a township street. Officers attempted to verbally de-escalate the male on two occasions encouraging him to stay inside his residence. On a third occasion the male left his property and was on a neighbor's property when officers were resummoned. Officers determined that the male was a danger to himself and others and attempted to take him into custody by handcuffing him behind his back. The male resisted and officers were forced to control each of his arms until they could successfully handcuff him behind his back. The male also resisted when officers were attempting to apply a leg shackle while at our station typing charges. No injuries were reported by the male or the officers dealing with the male.

Community Relations:

- Ofc. Sunderland installed two child safety seats for a township resident.
- Ofc. Shaffer, Ofc. McCaslin, and Ofc. Kauffman participated in the torch run on 5/16. The torch, which begins its journey from PNC Park in Pittsburgh, travels 150 miles to State College signifying the beginning of the Special Olympics. Officers volunteer to run the flame from Pittsburgh to our community.
- Many officers attended the Centre County Law Enforcement Memorial Service on May 18th. Chief Jolley read names of fallen officers and Ofc. Shaffer participated in the rifle team.
- Chief Jolley hosted the confirmation class from the St. John Lutheran Church in Bellefonte. The class toured the station and learned about how law enforcement helps the community.
- Det. Snyder and Ofc. Tuskovich gave a Tactical Response Team presentation to students at CPI.

- Officers were active in the school zones during drop off and pick up hours.

Training and Department Activities

Det. Snyder, Ofc. Shaffer and Ofc. Tuskovich attended Tactical Response Team training on 5/9.

All officers received yearly update training on First Aid/CPR/AED. Officers also received training on use of force and received a presentation from the Children's Advocacy Center.

Sgt. Shupenko attended training on Improvised Explosives.

Ofc. Vardzel attended Pedestrian and Bicycle Crash Investigation training.

Ofc. Sallade and Ofc. McCaslin attended Post Blast training put on by the FBI

Ofc. McElrath attended the Pennsylvania Gang Conference.

Ofc. Finochio attended an Anti-Terrorism Training Course.

Ofc. McCaslin and Ofc. Kauffman attended Rescue Task Force/Active Shooter Training.

All officers completed their MPOETC required yearly qualifications with handgun, shotgun, and patrol rifle. Critical Department Policies were reviewed, and officers were tested in the following areas: Use of Force, Deadly Force, Less Lethal Force/Weapons, Duty to Intervene, De-Escalation, Pursuit, Mental Health, Bias Based Policing, Special Stopping Techniques, Vehicle Immobilization Tactics, and Temporary Holding Rooms.

Chief Jolley attended a Centre Region Emergency Services meeting, the Centre County Law Enforcement Memorial Service, the Centre County Chiefs of Police meeting, the Children's Advocacy Center advisory committee meeting, the Happy Valley Business Association lunch, and assisted with Spring Township PD interviews for Sergeant.

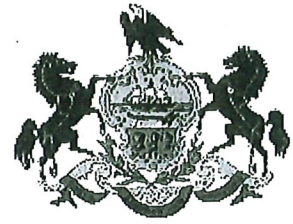

SUBJ: Performance Report

On 5/1/22, Ofc Kauffman and Ofc Wolfinger responded to a residence in Patton Township for a report of a male in cardiac arrest. Upon arrival the officers conducted an assessment and determined that the patient was not breathing and had no pulse. Ofc Wolfinger began chest compressions while Ofc Kauffman attached an AED to the patient. The AED ultimately delivered two shocks to the patient. In the meantime, the two officers continued giving chest compressions and rescue breaths to the patient until they were relieved by EMS. The patient eventually regained a pulse and was transported to Mount Nittany Medical Center for more advanced care. As of the following day the patient was being treated in the intensive care unit.

It was due to the quick actions of Ofc Kauffman and Ofc Wolfinger that a patient in cardiac arrest was revived and transported for more advanced care. Their actions reflect the highest credit on themselves and the Patton Township Police Department.

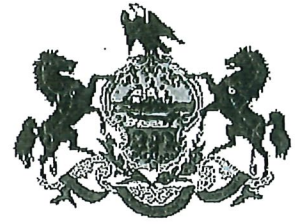

SUBJ: Performance Report

On 5/11/22, Ofc Soohoo responded to the Olive Garden restaurant for a report of a female choking on food. It was reported that the patient could not speak or breathe and that her lips were beginning to turn blue. When Ofc Soohoo arrived, he found the patient still choking. He immediately began first aid and administered a series of back blows and abdominal thrusts. This partially dislodged the obstruction and the patient was able to exchange some air. EMS arrived and took over care of the patient and transported her to Mount Nittany Medical Center for more advanced care.

It was due to the quick actions of Ofc Soohoo that a life-threatening choking incident was stopped and the patient was able to be transported for more advanced care. His actions reflect the highest credit on himself and the Patton Township Police Department.
